It is required that all students attending a school field study, a school trip, or a school sponsored event meet certain academic, behavioral, and attendance standards. Please note that the behavior contract is a PVA expectation, not an optional agreement, and will remain in effect regardless of whether this form is returned.

**PLEASE NOTE: By initialing and signing below you acknowledge the following:**

\_\_\_\_\_ I understand that in order for my child to attend a school field study, school trip or a school sponsored extracurricular activity this year, he/she must not have any of the following: outstanding balances, overdue/lost books, or excessive (5 or more) unexcused absences.

\_\_\_\_\_ I understand that my child must be in good academic standing and passing at least five classes at the time of the field study.

\_\_\_\_\_ I understand that my child MUST exhibit model behavior both in school and out in the community by always displaying PVA PRIDE. Unacceptable behaviors, which result in the following consequences at any time during the school year, will not be tolerated and will be grounds for immediate removal from the trip or activity (pending admin. review).

\_\_\_\_\_ My child must not have more than 2 days of in-school suspension per quarter

\_\_\_\_\_ My child must not have 1 or more days of out-of-school suspension

\_\_\_\_\_ My child must not have any pending/levied citations or charges against them

*\*Please note, ONE FULL day of ISS is equivalent and considered to be 7 periods of instruction\**

We understand the safety and well being of all participants on a trip is affected by each individual's behavior. We further understand that any behavior on the trip endangering the safety or well-being of others will not be tolerated and can result in the student being sent home at the parent's expense. All St. Johns County school rules and any hotel or transportation carrier's rules will apply at all times.

For any trip, we reserve the right to use Police K-9s in order to detect any drug paraphernalia that may be packed in bags or suitcases before the trip begins. \*8<sup>th</sup> Grade - If it becomes necessary to cancel your child's trip due to the reasons above, you will be refunded for the Washington DC monies paid to the tour company as stated by the tour company's refund schedule.
